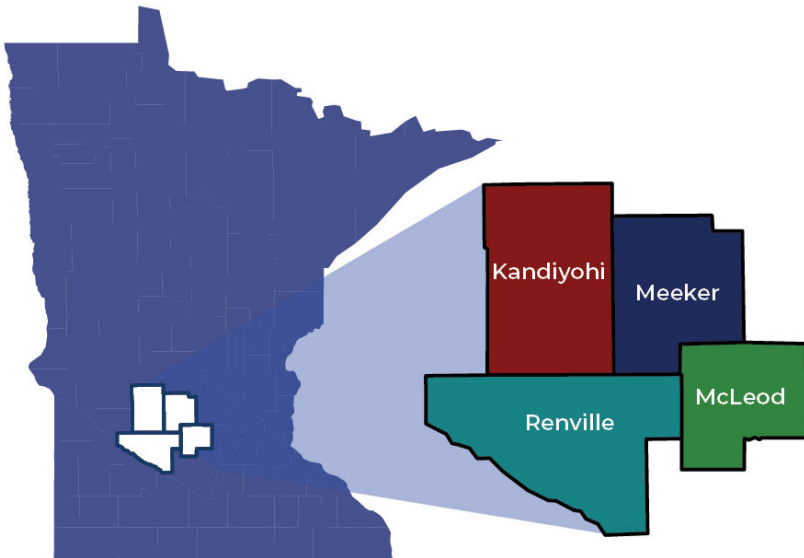


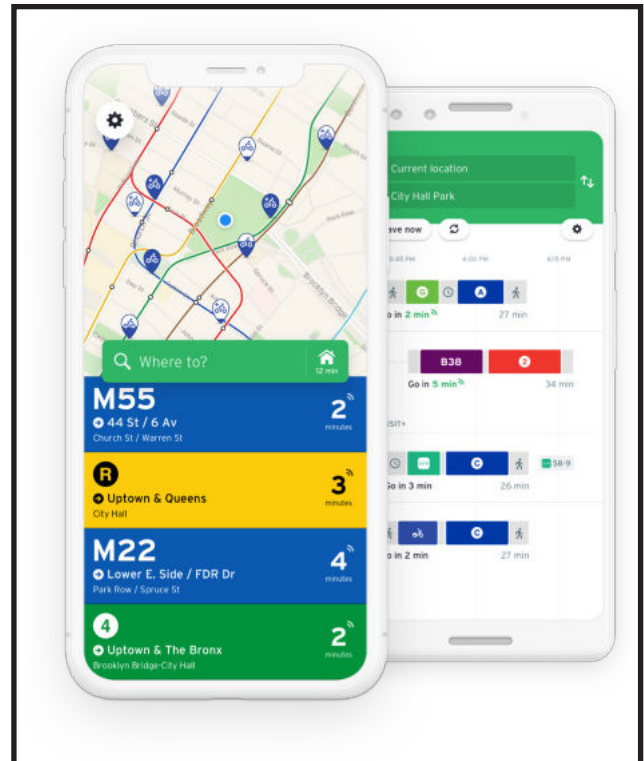
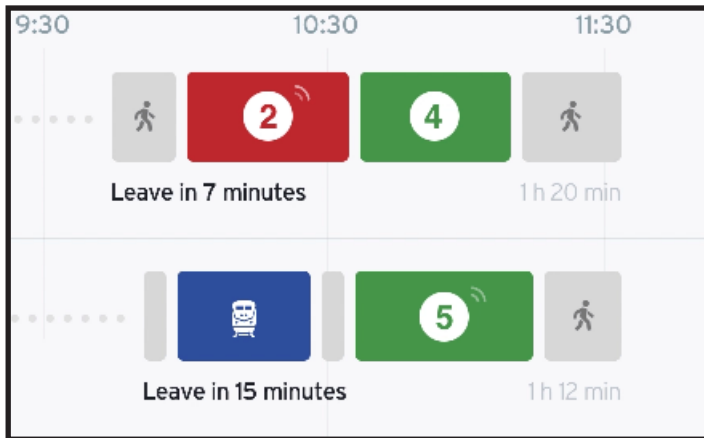

TRANSIT Mobile Device Application

Transit is a mobile app providing real-time public transit data. The app functions in over 175 metropolitan areas around the world. Transit was designed for aggregating and mapping real-time public transit data, crowdsourcing user data to determine the true location of buses and trains. Transit was first released in 2012 for iPhone and soon after launched the Android-compatible version. It offers users schedules and alerts for multiple modes of transportation where available, including bus and rail.

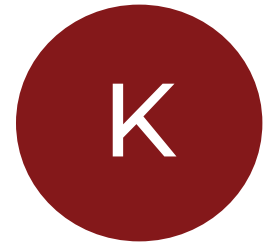
