Community & Transportation Planning Services: MMDC helps communities develop tailored plans that can position them for sustainability, development, and a high standard of living.

Comprehensive Planning: Comprehensive plans are foundational to Community planning. They outline a community's vision, goals, and policies to support various aspects of development (e.g., land use, housing, transportation, services, and infrastructure). These 10- to 15-year plans guide decision-making to ensure thoughtful, organized, sustainable, and balanced growth.

Historic Preservation & Rehabilitation Planning: This planning process helps communities devise strategies and processes that protect, conserve, and adapt historic buildings and sites for new uses while preserving their historical significance. The process promotes progress while preserving local character.

Preliminary Planning Studies: Before pursuing a major project, it's important to first assess its feasibility and long-term viability. Preliminary planning studies can save communities money by providing an opportunity to refine strategies to support project efficiency and successful outcomes. These studies often involve coordination between planners, engineers, architects, and/or other specialists.

Parks, Trails, and Recreation Planning: This type of planning helps communities ensure their shared spaces are preserved and improved to meet environmental needs, promote physical and mental wellbeing, enhance quality of life, and provide venues for positive resident interaction.

Walk & Bike Audits: These audits are a process of systematically assessing safety, comfort, and connectivity for those who choose to walk or bike to their local destinations. The focus of a walk or bike audit could be a neighborhood or, in the case of smaller towns, the entire community. They can be provided as a standalone service or as part of a larger Active Living Transportation or Safe Routes to Schools Plan.

Active Transportation Planning: Active transportation plans outline strategies and actions to improve conditions for walking, biking, and other forms of human-powered transportation. These plans aim to create a safer, more accessible, and more convenient transportation system to encourage physical activity.

Safe Routes to School Planning: Safe Routes to School (SRTS) is a comprehensive approach to improving the safety, convenience, and the appeal of walking and bicycling to and from school. It involves a combination of infrastructure improvements, educational programs, encouragement initiatives, and enforcement strategies, all aimed at making it safer and more attractive to walk or bike to school.
